**ACCEPTABLE CLEARINGHOUSES**

Evidence-based practices are “gold standard” programs – those programs that have been empirically proven to produce positive outcomes and that are implemented in Sonoma County with fidelity to the model program. Upstream Investments requires evidence-based practices on the Portfolio be listed on an evidence-based clearinghouse and implemented with fidelity in Sonoma County. This document includes approved clearinghouses and the ratings on each clearinghouse that allow for Portfolio inclusion. New clearinghouses are added as they become known to and approved by the Portfolio Review Committee. ## NOTES

- No evidence of harm is also required as a pre-requisite for all sites.
- Peer review may be evidenced by publication in a peer reviewed journal or peer review by the clearinghouse reviewers.
- The Upstream Investments initiative originally included a requirement for sustained effect of at least 6 months. However, this criterion is not yet universally accepted by all clearinghouses. Therefore, this criterion is no longer required for placement on the Upstream Portfolio.
- Not all clearinghouses included evidence of replicability in their review.
